We hereby authorize the alarm company to issue code cards to the persons listed on the previous page. These persons will have authority to enter our premises during closed periods by first telephoning Central Station in advance of such entry, giving their name, code word and approximate time the premises will be entered, and again telephoning your Central Station after entering and instructing your operators as to the approximate time the premises will be closed.

Company shall have the right to assign this agreement to any other person, firm or corporation without notice to the subscriber and shall have the further right to sub-contract any installation and/or services, including monitoring.

It is understood that the company is not an insurer, that insurance, if any, shall be obtained by the subscriber and that the amounts payable to the company hereunder are based upon the value of the services and scope of liability as herein set forth and are unrelated to the value of the subscriber's property or others located in subscriber's premises. The company makes no guarantee or warranty, including any implied warranty of merchantability or fitness, that the system or services is designated to detect. It is impractical and extremely difficult to fix the actual damages, if any, which may proximately result from failure on the part of the company to perform any of its obligations hereunder. The subscriber does not desire this contract to provide for full liability of the company and agrees that the company shall be exempt from liability for loss or damage due directly or indirectly to occurrences or consequences therefrom, which the service or system is designed to detect or avert that if the company should be found liable for loss or damage due to a failure of service or equipment in any respect, its liability shall be limited to a sum equal to ten percent of the annual service charge or \$250.00 whichever is the greater, as liquidated damages and not as a penalty, as the exclusive remedy and that the provisions of this paragraph shall apply if loss or damage, irrespective of cause of origin, results directly or indirectly to person or property from performance or nonperformance of obligations imposed by this contract or from negligence, active or otherwise, of the company, its agents or employees. If the subscriber desires the company to assume a greater liability, company will amend this agreement to allow the subscriber to pay an additional annual amount necessary to purchase an insurance policy for such greater liability. No such amendment shall be effective unless signed by the subscriber, company and insurance carrier, which will be insuring the additional liability. Late charges accrue @ \$5.00 per month following the 15<sup>th</sup> of the month.
